ORDINANCE #2022-02.5

AN ORDINANCE AMENDING THE CITY OF VIBORG PERSONNEL POLICY SECTION 6.10 <u>HOLIDAYS</u> TO INCLUDE MARTING LUTHER KING JR. DAY, JUNETEENTH, AND NATIVE AMERICAN DAY TO THE CITY OF VIBORG.

WHEREAS, THE CITY OF VIBORG, SOUTH DAKOTA HAS DETERMINED IT WISHES TO FOLLOW FEDERAL, STATE, BANK AND SCHOOL HOLIDAY CALENDARS. THE STATE OF SOUTH DAKOTA RECOGNIZES THE FOLLOWING 11 LEGAL, PAID, HOLIDAYS (per SDCL 1-5-1), PLUS ANY OTHER DAY PROCLAIMED A HOLIDAY BY EITHER THE GOVERNOR OF SOUTH DAKOTA OR THE PRESIDENT OF THE UNITED STATES.

NOW, THEREFORE BE IT, RESOLVED BY THE CITY OF VIBORG AS FOLLOWS:

The City of Viborg's Personnel Policy Section 6.10 Holidays shall be amended to include Martin Luther King Jr., Day, Juneteenth, and Native American Day, to now read as follows:

6.10 Holidays.

The following calendar days and such other days as the Viborg City Council may fix are deemed holidays for full-time municipal employees:

New Year's Day

Martin Luther King, Jr. Day (3rd Monday in January)

President's Day (3rd Monday in February)

Good Friday – ½ day (afternoon)

Memorial Day

Juneteenth (June 19th)

Independence Day (July 4th)

Labor Day (First Monday in September)

Native American Day (2nd Monday in October)

Veteran's Day (November)

Thanksgiving Day (4th Thursday in November)

Christmas Eve (December 24th) ½ day (afternoon)

Christmas Day (December 25th)

OR all other days proclaimed as legal non-working holidays by the President of the United States or the Governor of South Dakota.

When any of the above holidays falls on a Saturday, the preceding Friday shall be observed as the holiday; and when any of the above holidays falls on Sunday, the following Monday is considered the holiday.

An employee on unauthorized leave without pay the day prior to a holiday shall not be paid for the holiday.
