## ORDINANCE NO. 2014-11

AN ORDINANCE OF THE CITY OF VIBORG, SD, AMENDING THE REVISED MUNICIPAL ORDINANCES OF THE CITY OF VIBORG BY AMENDING CHAPTER 7.05, PARKING, STOPPING.

BE IT ORDAINED BY THE CITY OF VIBORG, SD:

Section 1. That Section 7.0507, of the Revised Municipal Ordinances of Viborg, SD, is hereby amended to read as follows:

- 7.0507 Parking Prohibited in Certain Places. At any time it shall be unlawful to permit any vehicle to stop, stand, or park in any of the following places, except when necessary to avoid conflict with other traffic or in compliance with the directions of a law enforcement officer or traffic control device:
  - A. In any intersection;
  - B. In a crosswalk;
  - C. Within fifteen feet (15) of a fire hydrant;
  - D. At any place where the vehicle would block the use of a driveway;
  - E. Within fifteen (15) feet of the driveway entrance of a fire department station;
  - F. On any sidewalk;
  - G. At any place where the vehicle would block the use of a sidewalk;
  - H. In any portion of a street so designated as a fire lane;
  - In any portion of a street so designated as a traffic lane;
  - J. At any place where official signs prohibit parking;
  - K. Inside of curb, on street right-of-way. Area between the back of the curb to the property line
  - L. Parking of any vehicle on any City street for the purpose of camping or sleeping;
  - M. No person shall park any a) farm tractors, farm wagons, or any other farm implements; or b) any recreational vehicle on any street within the City for a period longer than seventy-two (72) hours. Recreational vehicle(s) and farm implement(s) shall be tagged by a law enforcement officer and a warning issued to remove within twenty-four (24) hours. Failure to do so will result in removal by the City at the owner's expense. For purposes of this Section, recreational vehicle is defined to include, but shall not be limited to, the following:

- 1. Cargo trailers;
- 2. Travel trailers;
- 3. Pickup campers or coaches;
- Motorhomes;
- 5. Camping trailers;
- 6. Boats and boat trailers;
- Snowmobiles and snowmobile trailers;
- 8. Jet skis and jet ski trailers;
- Golf carts and golf cart trailers;
- 10. All-terrain vehicles and all-terrain vehicle trailers;
- Dirt bikes and dirt bike trailers;
- 12. Car trailers; and
- 13. Any other recreational equipment or cases, boxes or items used to store or transport such recreational equipment.
